4. I confirm that I do not have any physical limitations, medical ailments, or physical or mental conditions that would limit or prevent me from participating in the Activity. If I have any concerns about my fitness to participate, I will obtain appropriate medical clearance prior to attending.

I, THE UNDERSIGNED, AM THE PARTICIPANT IN THE ACTIVITY AND I HEREBY CONSENT TO PARTICIPATE IN THE ACTIVITY AND, IN RETURN FOR SPEC ALLOWING ME TO PARTICIPATE IN THE ACTIVITY:

- 1) **I NOW WAIVE ALL LEGAL RIGHTS TO SUE AND ANY AND ALL CLAIMS** which I and/or my successors and assigns may have against SPEC in connection with any loss, injury, damage, or expense that I may suffer, incur, or experience in connection with my participation in the Activity; and

- 2) **I HEREBY RELEASE** SPEC from any and all liability for any complaints, demands, claims, actions, suits, judgements, and orders for, or with respect to, any and all losses, injuries, damages, or expenses I may suffer, incur, or experience in connection with my participation in the Activity; and
- 3) **I AGREE TO INDEMNIFY** SPEC for, and hold it harmless from, any and all losses, injuries, damages, and expenses of any kind that SPEC may suffer, incur, or experience as a result of my participation in the Activity.
